RESOLUTION 2016-3

RESOLUTION REPEALING RESOLUTION 2015-11/REGARDING INSURING WATERCRAFT OPERATED UPON CORDRY AND SWEETWATER LAKES

WHEREAS, the Cordry-Sweetwater Conservancy District is an Indiana conservancy district organized pursuant to I.C.14-33; and,

WHEREAS, I.C.14-33-5-20 provides in part that the board of directors of Cordry-Sweetwater Conservancy District shall exercise general supervision of and make regulations for the administration of the affairs of the district; and,

WHEREAS, the Cordry-Sweetwater Conservancy District owns, maintains and operates, as part of its works of improvement, Cordry Lake and Sweetwater Lake; and,

WHEREAS, Cordry Lake and Sweetwater Lake are large fresh water bodies of water upon which are operated, under license of the Board of Directors of the Cordry-Sweetwater Conservancy District, watercraft, both powered and non-powered; and,

WHEREAS, Cordry and Sweetwater Lakes experience a high volume of watercraft traffic, especially during seasonal periods; and,

WHEREAS, it appears to the Board of Directors of the Cordry-Sweetwater Conservancy District that, in order to provide for the safety and security of users of Cordry and Sweetwater Lakes, it would be in the best interests of the freeholders of the Cordry-Sweetwater Conservancy District to require that all gasoline powered watercraft utilizing Cordry and Sweetwater Lakes be covered by liability insurance, insuring the owner and/or operator of the watercraft against liability for personal injury or property damage caused in connection with the operation of the watercraft; and,

WHEREAS, it appears to the Board of Directors of the Cordry-Sweetwater Conservancy District that the amount of liability insurance applicable to each gasoline powered watercraft using Cordry and Sweetwater Lakes be in an amount no less than \$100,000.00 per person and per occurrence.

NOW BE IT THEREFORE RESOLVED by the Board of Directors of the Cordry-Sweetwater Conservancy District that:

1. Resolution 2015-1 b is hereby repealed.

- **2.** Resolution 2004-03, Operation of Watercraft (1), be amended by adding an additional sub-paragraph (r) stating:
 - "(r) Prior to registering a gasoline powered watercraft and obtaining a decal, a person seeking to register a gasoline powered watercraft must present to the District Office proof of liability insurance applicable to the watercraft to be registered in an amount not less than \$100,000.00 coverage, insuring against bodily injury or property damage."
- 3. No gasoline powered watercraft may be registered, nor a decal issued for said watercraft, until such time as the person seeking to register the watercraft provides proof of insurance as required pursuant to this Resolution.
- 4. The requirement to maintain insurance upon watercraft shall be a continuing requirement. Any lapse or cancellation of insurance coverage will result in the immediate revocation of the watercraft's decal and said watercraft shall no longer be permitted upon Cordry or Sweetwater Lakes until such time as the insurance coverage required by this Resolution is reinstated.
- 5. This Resolution shall be in full force and effect from and after its passage.
